

Invoices will be sent on or about the 15th day of each month via email and must be paid to RASM within 10 days upon receipt. If payment is not made within 10 days of receipt, the account will accrue interest until paid at the rate of 18% per annum and a late fee of \$25 will be charged every month there is an unpaid balance. If payment is not received during the term of a multi-month contract, then future ads will not be placed in the magazine until such payment of all applicable interest, late fees, and balance due are received. All payments on the account shall be applied in the following manner: first to interest, then to the late fees, then to attorney's fees, if applicable, and then to the ad charge or balance due. In addition, the advertiser will be fully responsible for any costs incurred for action taken on the account to include attorney's fees and court costs. Any legal action for collection shall take place in Sarasota County and Florida law shall govern.

## MEMBER DISCOUNTS
