*** ARTICLE IV, Section 1 (a)-in part “REALTOR® Members.**

Realtor Members, whether primary or secondary, shall be;

(1) Individuals who, as sole proprietors, partners, corporate officers, or branch managers, are engaged actively in the real estate profession, including buying, selling, exchanging, renting or leasing, managing, appraising for others for compensation, counseling, or financing, building, developing, or subdividing real estate, and who maintain or are associated with an established real estate office in the state of Florida or a state contiguous thereto.”

*** ARTICLE IV, Section 1 (b)-Institute Business Partner Members.**

Institute Business Partner Members shall be individuals who hold a professional designation awarded by an Institute, Society or Council Business Partnered with the NATIONAL ASSOCIATION OF REALTORS® that addresses a specialty area other than residential brokerage or individuals who otherwise holds a class of membership in such Institute, Society or Council that confers the right to hold office. Any such individual, if otherwise eligible, may elect to hold REALTOR® membership, subject to payment of applicable dues for such membership.
